

## **POWER OF ATTORNEY**

With the power and authority to subject properties, received or sent in the name of our company, to any customs approved processes or usage of all kinds of properties, to be subjected to the Entrance to Free Circulation, Transit, Customs Warehouses, Internally Processing, Processing under control of Customs, Temporary Importing, Externally Processing, and Export Regimes, to request Binding tariff or Binding Origin Information related with the property, in connection with the application transactions of exempt and exceptional provisions, for all permissions from official departments as well as all kinds of customs transactions, under the powers and liabilities, imposed to customs brokers by the regulations, below customs administration, free zone, exporter and importer associations, Regional Trading Directorates, Agricultural Quarantine, Hygiene Departments, Veterinary Directorates, Turkish Standards Institute, Governorships and Consulates, Undersecretariat of Treasury, Undersecretariat of Foreign Trading, Ministry of Economy, Undersecretariat of Customs, Petroleum Affairs General Directorate, Ministry of Labor and Social Security, Ministry of Health, Ministry of Industry and Commerce, Commercial Stock Markets, Agricultural City Directorates, banks, exchange offices, chambers of Commerce and Industry, ports, warehouses, depots, making Turkish Radio and Television Corporation (TRT) banderol application, getting TSE banderole and related other entities as well as all governmental departments, including central and rural organizations, to follow-up and conclude invoices, certificates of origin, ATR, EURO – 1, insurance policies, encouragement certificates, expertise reports, bills of lading, shipment receipts and packing lists, to be submitted to them by us and of which accuracy and genuineness are under our responsibility, as well as royalty and license payments, which might affect the value, on condition to have a relation between seller and us as well as compatible with the documents, completion and undersigning of the value statements, and to execute transactions of all kinds of documents, required by entry and exit transactions and such as warranty exemption certificate, TSE, Tareks applications, Control, INF Information Forms, T5 Certificate, measurement calibration, radiation security, to receive, undersign and endorse the bills of lading, to execute and let third persons to execute loading, discharge and delivery transactions, to dispatch and transport the property, and to issue, let third persons to issue and undersign reports, minutes and reservation memorandums, to object to warehouse fees below agencies and warehouses as well to follow-up and inspect property, and in case of a damage on the property, to request an expert, to let him to make determinations, to deposit amounts, such as taxes, dues, charges, securities, deposits, overtime, travel allowances, allowances and freights, to receive their documents, to execute objection transactions of these, to receive back these deposited documents, to receive back such deposited amounts, to deliver and take delivery of the documents related with these, to conclude and submit letter of undertaking, to undersign the letters of undertaking, showing the usage principles of the system related with acceptance and approval of documents and statements related with export in electronic means via using network, submitted under e-association project by General Secretariat of Exporter & Importer Associations, and with payment of charges and subscriptions via using same technology, and to undersign contracts, showing the usage principles of above mentioned system, to receive the passwords and IDs, to be required for usage of above mentioned system, and to transact inland and abroad, to deliver documents related with all kinds of transactions, like triple traffic, temporary import and export, etc., to competent authorities, to follow the transactions below these authorities, to receive the issued documents, and to execute and conclude all transactions, which can be executed by us in connection with laws and regulations for custom transactions of the

property, to claim and receive the moneys, excessively deposited to customs, ports and special warehouses, to recover money, in connection with the methods and principles related with the mediation according to the 244<sup>th</sup> article of Customs Law; to enter mediation, to act in my name related with mediation transactions, to follow and conclude, in case of a need, to authorize its personnel in order to execute or let third persons to execute in our name, with any part or all of these powers, or to appoint attorneys, to delegate, collaborate and dismiss others as well as to act jointly or individually.
